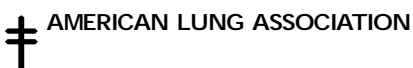

In consideration of my application and permitting me to participate in The 24 Hours of Landahl, I hereby take action for myself, my executors, administrators, heirs, next of kin, successors, and assigns as follows: (A) Waive, Release and Discharge from any and all liability for my death, disability, personal injury, property damage, property theft or actions of any kind which may hereafter accrue to me including attorney's fees, litigation costs, and my traveling to and from The 24 Hours of Landahl, THE FOLLOWING ENTITIES OR PERSONS: Granny Gear Productions, Inc., The American Lung Association, LLC, Jackson County Parks and Recreation, and any involved municipalities, their directors, officers, employees, volunteers, representatives and agents, the event holders, event directors, event sponsors, vendors, event volunteers, property owners; (B) Indemnify and Hold Harmless the entities or persons mentioned in this paragraph from any and all liabilities or claims made as a result of participation in The 24 Hours of Landahl, whether caused by the negligence of releasees or otherwise.

I agree that all disputes arising under this contract and/or from my use of the facilities at this event shall be litigated exclusively in the Circuit Court of Tucker County, West Virginia or in the US District Court for the Northern District of West Virginia.
